BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTES OF THE VILLAGE OF MCLEAN, MCLEAN COUNTY ILLINOIS

**SECTION 1:**

The Budget and Appropriation Ordinance No. 15-06 adopted by the Board of Trustees of the Village of McLean on July 6, 2015 is hereby amended by deleting Section 5 and in place thereof substituting a new Section 5, which is as follows:

**SECTION 5:** 65 ILCS 11-74.4-55(j) requires the Village to include in its annual budget certain information regarding the Village's tax increment finance district. Specifically, the Village is required to set forth in its annual budget the revenues generated from the redevelopment project areas by source and the expenditures made by the Village for redevelopment project areas. In compliance with the provisions of this Act, the Village of McLean has caused to be attached hereto Exhibit A, incorporated herein by reference, setting forth the revenues generated from redevelopment project areas by source and the expenditures made by the Village for redevelopment project areas.

**SECTION 2:**

Except as modified and changed by this Supplemental Budget and Appropriation Ordinance, the original Appropriation adopted on July 6, 2015 shall remain in full force and effect.


**SECTION 3:**

If any section, subdivision or sentence of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.


**SECTION 4:**

A certified copy of the Supplemental Budget and Appropriation Ordinance shall be filed with the County Clerk of McLean County, Illinois, within 30 days after adoption.
