ORDINANCE NO. 16- 01-04

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO WATER RATES, SEWER RATES, UTILITY CHARGES AND TO CREATE A DEBT SERVICE FEE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §171.02(A) of the Village Code of the Village of McLean is hereby amended by deleting the words "water and sewer".

SECTION 2: §171.02(B) Utility rates of the Village Code of the Village of McLean is deleted and in its place a new subsection is added which is as follows:

§ 171.02(B) *Utility rates.* There shall be a minimum rate of 2,000 gallons for all users. The following rates shall apply to water that is delivered to a customer.

(1) Water rates.

Gallons per Month	Residential Rate per 1,000 Gallons	Commercial and Bulk* per 1,000 Gallons
2,000-6,000 gallons	\$7.70 **	\$9.90 ***
6,001 and over	\$9.13	\$9.90
*Bulk water is defined as any water used that was not metered. ** Minimum monthly residential rate charge is \$21 ***Minimum monthly commercial & bulk rate charge is \$27		

(2) Sewer rates.

Gallons of Water Used per Month	Residential Rate per 1,000 Gallons	Commercial per 1,000 Gallons
2000-6,000 gallons	\$3.50 **	\$4.25***
6,001 and over	\$3.90	\$4.25
Minimum monthly residential rate charge is \$10.50 * Minimum monthly commercial charge is \$12.75		

SECTION 3: §171.02 of the Village Code of the Village of McLean is hereby amended by re-lettering sub-paragraph (D) *Late penalties* to (D) *Late penalties* and inserting a new sub-paragraph (D), which is as follows:

§171.02(D) *Debt Service Fee.* Each service connection shall be charged a debt service fee of \$9.30 per month. This debt service fee shall be added to each bill.

If for any reason a service connection has been shut off the debt service fee shall continue to be charged.

SECTION 4: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 5: This Ordinance shall take effect on the 20 day of FEB., 2016.

SECTION 6: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
