ORDINANCE NO. 16-06-06A

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO INACTIVE UTILITY ACCOUNT

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: A new subsection (E) is added to §171.02 of the Village Code of the Village of McLean, which is as follows:

§171.02(E) Inactive Service

- (1) A residential or commercial service that is not active shall not be obligated to pay any fees when, and only when the service is inactive.
- (2) A residential or commercial service is inactive if ALL of the following conditions are present:
 - (a) The water service has been turned off by the Village.
 - (b) The recipient of service is not delinquent in the payment of any utility bill.
 - (c) The residential or commercial service is not occupied.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
