An Ordinance Appropriating Sums of Money Necessary to Defray All
Expenses and Liabilities Of the Village of McLean, McLean County, Illinois 61754
For the Fiscal Year Beginning May 1, 2016, And Ending April 30, 2017
(Illinois Municipal Code, 65 ILCS 5/8-2-9)

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF MCLEAN, McLean County, ILLINOIS 61754:**

SECTION 1: The sums that are hereinafter set forth, or so much thereof as may be necessary and may be authorized by law, are hereby appropriated for the purposes hereinafter set forth of the Village of McLean, McLean County, Illinois, to defray all necessary expenses and liabilities of said Village, as hereinafter specified, for the fiscal year beginning May 1, 2016 and ending on April 30, 2017.

SECTION 2: That the amount appropriated for all corporate purposes of the Village of McLean for the fiscal year beginning May 1, 2016, and ending April 30, 2017, summarized by fund, shall be as follows:

SECTION 3: Appropriations for Street and Bridge purposes shall include, to the extent they are not already included in the above, all monies received by the State of Illinois as Village's proportionate share of Motor Fuel Taxes, and shall further include, to the extent they are not included in the above, all monies received from the Township of McLean, Illinois, Road and Bridge fund, as provided by law.

SECTION 4: Should there be appropriated for any item more than is used, the unexpended balance of the appropriation for such item may be used in making up any deficiency as to any item permitted by law. The sums herein appropriated are appropriated from all sources of revenue, including, without limiting the foregoing, income from rentals, franchise payments, retailer's occupation tax, retailer's service tax, municipal share of the state income tax, utility taxes, bonds, grants and all other revenues of the Village.


SECTION 5: Section 11-74.4-55(j) of the Tax Increment Allocation Redevelopment Act requires the Village to include in its annual budget certain information regarding the Village's tax increment finance district for the proceeding fiscal year. Specifically, the Village is required to set forth in its annual budget the revenues generated from redevelopment project areas by source and the expenditures made by the Village for redevelopment project areas.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage and due publication thereof, as required by law.

SECTION 7: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.


SECTION 8: The Clerk of this Village is hereby directed to file with the County Clerk of McLean County, Illinois, a duly certified copy of this Ordinance.
