ORDINANCE NO. 19-01-07

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO STORAGE OF VEHICLES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §72.13 of the Village of Code of the Village of McLean is hereby amended in the following manner and method:

1. The entire contents of **§72.13 Storage of Vehicles.** is transferred to a new Chapter 140.
2. §72.13(A) is renumbered "140.01"
3. §72.13(B) is renumbered "140.02"
4. §72.13(C) is renumbered "140.03"
5. §72.13(D) is renumbered "140.04"
6. §72.13(E) is renumbered "140.05"
7. §72.13(F) is renumbered "140.06"

SECTION 2: The foregoing new chapter of 140 of the Village Code of the Village of McLean is hereby amended by adding at the beginning of that new chapter a summary of the sections and titles of the sections for Chapter 140.00.

SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No. 96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
