ORDINANCE NO. 21-04-05

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO OPEN BURNING

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §93.32 of the Village Code of the Village of McLean is hereby amended by deleting (D)(1)(a) and substituting a new sub-section (a) which is as follows:

§93.32(D)(1)(a) The burning takes place in the months of March, April, October, or November and takes place between the hours of 8:00 a.m. and sunset Monday through Saturday and between the hours of 1:00 p.m. through sunset on Sunday.

SECTION 2: §93.35 of the Village Code of the Village of McLean is hereby deleted from the Village Code.


SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
