ORDINANCE NO. 21-04-05A

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO DOG OR ANIMAL EXCRETA

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §96.01(H) of the Village of Code of the Village of McLean is hereby amended by adding after the existing provisions of that subsection the following additional provisions:

§96.01(H) of the Village Code. In addition to the foregoing nuisances, it shall be a nuisance for any person that has a dog or animal under their control on any property within the Village to fail to remove dog or other animal excreta that was deposited by the dog or animal under their control. In addition, when walking a dog or other animal or otherwise having a dog or other animal under their control, it is a nuisance for a person to not have on their person a suitable means for removal of such excreta.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
