AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE
SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A
OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS
RELATING TO GOLF CARTS AND NEIGHBORHOOD VEHICLES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §71.108 of the Village of Code of the Village of McLean, is hereby amended by adding a new Subsection G, which is as follows:

§71.108 G: Golf Carts and Neighborhood Vehicles must be registered with the Village of McLean before they travel as authorized by this chapter and must be registered with the Village of McLean Police Department on an annual basis by on or before May 1 of each year. The Village Board of Trustees shall establish a fee for the annual registration to provide for the cost of administration.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §71.108 of the Village of Code of the Village of McLean is hereby amended by adding a new Subsection G, which is as follows:

§71.108 G: Golf Carts and Neighborhood Vehicles must be registered with the Village of McLean before they travel as authorized by this chapter and must be registered with the Village of McLean Police Department on an annual basis by on or before May 1 of each year. The Village Board of Trustees shall establish a fee for the annual registration to provide for the cost of administration.
