ORDINANCE NO. 22-06-06 A

AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL PROPERTY

WHEREAS:

(1) It is the opinion of at least a majority of the Trustees then holding office in the Village of McLean that it is no longer necessary or useful or for the best interests of the Village of McLean to continue to own and keep the following described personal property:

2010 Ford Crown Vic, Police Interceptor, black and white, VIN#2FABP7BVOAX129306, approximately 121,351 miles, 4.6L engine with automatic transmission, power windows, power steering, power brakes, key fob, cloth bucket seats in the front, spot light in back.

(2) Whereas 65 ILCS 5/11-76-4 authorizes the Village of McLean to sell personal property that is no longer necessary, useful to or for the best interest of the Village to continue to own.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN, MCLEAN COUNTY, ILLINOIS, AS FOLLOWS:

Sec. A. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of the Ordinance.

Sec. B. The item of personal property described in the foregoing paragraph 1 of the foregoing recitals may be sold AS IS through a public sale as designated by the President and Board of Trustees of the Village of McLean with advertising same.

Sec. C. It is no longer necessary or useful or for the best interests of the Village of McLean to continue to own the item of personal property described in paragraph 1 of the foregoing recitals.

Sec. D. The bids received through the advertisement described in Sec. B shall be opened by the Board of Trustees on the 12<sup>th</sup> day of September, 2022 at 7:05 p.m. At that date and time any bidder who is personally present may verbally increase their bid. The Village reserves the right to reject any and all bids.

Sec. E. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
