**SUPPLEMENTAL APPROPRIATION ORDINANCE FOR THE VILLAGE OF MCLEAN
IN MCLEAN COUNTY, ILLINOIS**

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law and as may be needed or deemed necessary to defray all expenses and liabilities of Village of McLean, be and the same are hereby appropriated on a Supplemental basis for General Fund Purposes of the Village of McLean, McLean County, Illinois, as hereinafter specified for fiscal year beginning April 1, 2022 and ending March 30, 2023.

SECTION 2: The Appropriation Ordinance No. 22-06-06 adopted by the Village of McLean on June 6, 2022, is hereby amended as follows:

1. The total Appropriation for Parks, Recreation and Tourism from \$21,200.00 to \$22,200.00.
2. The total General Fund is changed by interlineation from \$592,143.69 to \$593,143.69.
3. The total appropriations are changed by interlineation from \$1,715,937.44 to \$1,716,937.44.
4. The word "Acting" beneath the signature of Aaron Hammel is deleted.

SECTION 3: Except as modified and changed by this Supplemental Appropriation Ordinance, the original Appropriation adopted on June 6, 2022, shall remain in full force and effect.

SECTION 4: The sums herein appropriated are appropriated on a supplemental basis from all sources of income, including but not limited to, all sources of income from property taxes and all revenues of the Village of McLean, meaning this Ordinance to appropriated from all sums received from all sources of revenue.


SECTION 5: Any deficiencies in any fund other than the General Fund, for a purpose for which money may be legally appropriated and spent from the General Fund, may be made up from the General fund. The amount of such deficiency in any such fund other than the General Fund is hereby appropriated from the General Fund.

SECTION 6: All unexpended balances of any item or items of General Funds or special appropriations made by Ordinance may be expended in making up any deficiency in any item or items in the same general purposes in like appropriations made by this Ordinance.

SECTION 7: If any section, subdivision or sentence of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 8: A certified copy of this Supplemental Budget and Appropriation Ordinance shall be filed with the County Clerk of McLean County, Illinois, within 30 days after adoption.




